



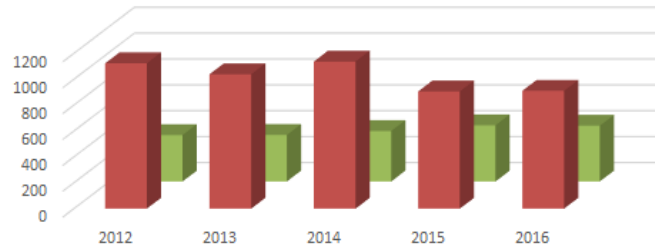

2016 Annual Report

The following medical services were provided by HPFC in 2016:

- 911 unduplicated patients seen
- 3,406 medical visits
- 2,393 labs/diagnostics
- 1,074 health insurance consults
- 239 Social Service consults
- 8,431 prescriptions dispensed at a value of nearly \$1 million
- Over \$1.8 million provided in total medical services

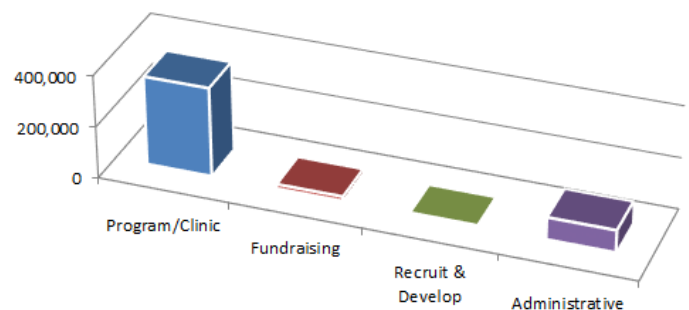
2016 Revenue

Fortunately, the Clinic has found support from local foundations, individuals, corporations, grantors, and local United Way agencies for many years. 2016 Expense

Health Partners directs eighty percent of our revenue towards Clinic programming alone. With good stewardship we were able to dispense \$5.55 in medical services for every \$1 spent.
